

# Medirox AB's privacy policy - information about processing personal data

### 1 Introduction

MEDIROX AB has taken measures to ensure that your personal data is always protected and processed in accordance with the General Data Protection Regulation (GDPR). Personal data is all data that can be used to identify you.

MEDIROX AB is the personal data controller for the processing of your personal data. Processing is carried out by employees of MEDIROX AB.

This information text describes how and why MEDIROX AB processes your personal data.

# 2 Processed personal data and basis for processing

### Personal data

# • **Identity details** (for example name)

- **Contact details** (for example telephone number)
- **Customer contact** (for example e-mail address)
- **Supplier contact** (for example e-mail address)
- Financial details (for example bank account details)
- Other information provided upon contact with us

### Legal basis for processing

- In order to run the company's operations.
- In order to fulfil the agreement entererd with you as a customer/supplier.
- According to a balance of interests.
- To fulfil legal obligations.
- By consent.

Data is also processed when MEDIROX AB contacts you and informs you about regulatory or condition changes, test results, products and services etc. that are related to the assignment you have given MEDIROX AB. Personal data is also processed when you as a customer electronically receive information from MEDIROX AB, for example via SMS, or e-mail.

Personal data about you that a customer/supplier may process after a balance of interests has been made between MEDIROX AB's legitimate interest for processing and your privacy interest.

Your personal data is processed and stored to fulfil legal obligations that MEDIROX AB has, such as to achieve and ensure sufficient customer due diligence, conduct checking of sanction lists, preserve documentation or disclose data to authorities upon request.

Your personal data is processed in accordance with the consent you have given MEDIROX AB. Data is processed with the purpose of performing the services you requested.



#### Contact with MEDIROX AB

We process your personal data when you contact us or when we contact you via e-mail, letter, contact form on our website or other method.

MEDIROX AB may process your personal data after a balance of interests has been made between MEDIROX AB's legitimate interest for processing and your privacy interest.

Personal data may be processed for MEDIROX AB's legitimate interest for establishing, claiming and defending legal claims.

### **MEDIROX AB partners**

MEDIROX AB may process personal data for employees of a partner for the purpose of communicating with the partner, managing the contractual relationship and managing the services agreed between the companies. This may regard, for example, the handling of invoices or attendance at conferences and other activities.

MEDIROX AB may process your personal data after a balance of interests has been made between MEDIROX AB's legitimate interest for processing and your privacy interest. Processing is necessary to satisfy MEDIROX AB's need to maintain the entered contractual relationship.

Personal data may be processed for MEDIROX AB's legitimate interest in establishing, claiming and defending legal claims.

#### 3 Data collection

We collect information about you from different sources.

We collect information about you as a customer/supplier from you when you become a customer/supplier. Collection also occurs when you sign up for a product or service via us, when you contact us or use any of our digital channels (for example e-mail).

With the purpose of maintaining good customer/supplier and registry assistance, MEDIROX AB may supplement personal data through collection from private and public registers.

#### 4 Parties that MEDIROX AB shares data with

Data may be shared with some service suppliers of MEDIROX AB, for example system suppliers and cloud based service suppliers. In these cases, the service supplier acts according to instructions from us and may not use the data for their own purposes.

We may also share personal data with authorities, including law enforcement agencies, in cases where we are obliged to do so. Such processing is necessary to fulfil legal obligations.



Personal data may also be shared with courts, counterparties and other parties involved in litigation. Personal data may be processed for MEDIROX AB's legitimate interest for establishing, claiming and defending legal claims.

MEDIROX AB may also share data with potential buyers and sellers if the business were to be sold or merged with another company. Such processing is necessary to fulfil our legitimate interest in completing the sale or merger.

# 5 Location for processing

MEDIROX AB processes data within the EU/EES. In the event of MEDIROX AB or a service provider of MEDIROX AB transferring personal data to a country outside the EU/EES, MEDIROX AB ensures that there are safeguards in place.

## 6 Storage of personal data

Your personal data is stored for as long as you are a customer/supplier of MEDIROX AB and after your agreement has ended, to the extent that the law requires it. This may, for example, regard keeping test results and agreements that show what MEDIROX AB and you have agreed upon.

Otherwise, personal data is only processed for as long as is necessary.

# 7 Your rights

#### Access to your data

You have the right to request access to the personal data we process about you, a so-called register extract.

#### Request correction

You have the right to request that incorrectly registered data about you is corrected.

#### Revoke consent

You have the right at any time to revoke any consent to the processing of personal data.

### Object to processing for direct marketing including profiling

You have the right to object to your personal data being used for direct marketing and to unsubscribe yourself from any customer mailings.

# Request restriction of processing

Under certain circumstances, you have the right to request that MEDIROX AB restricts the processing of your personal data. Under such circumstances, MEDIROX AB may not be able to fulfil our contractual obligations to you.



## Data portability

Under certain circumstances, and if it is technically possible, you have the right obtain the personal data registered about you in a structured, commonly used and machine-readable format and have the right to transfer this data to another party.

### **Deletion**

Under certain circumstances you have the right to have the data registered about you deleted. However, this does not apply if MEDIROX AB is required to keep the data by law.
